7. Responsible Financial Officer's Open Report

To receive the management Accounts for the period 1 April 2024 to 31 March 2025.

The RFO presented the final draft year end accounts prior to the Internal Audit which was due to take place on 5 June 2025. The bottom line shows a surplus of around £100k favourable to budget.

Questions from the previous meeting were confirmed as follows.

Q1. The £30k Cemetery Kerbing had been funded by CIL in 2023/24.

Q2. The cost of future elections had been further examined, in light of the increased charges for recent by-elections. There remained uncertainty regarding how the District Council intends to charge for the scheduled all-out Town elections in 2027. Calculations of potential costs for all wards formed part of the Earmarked reserves item discussed below.

8. To review and recommend the Earmarked Reserves for 31 March 2025.

The RFO presented calculations for options concerning Earmarked and General Reserves, which were discussed. It was agreed that priority should be given to restoring the General Reserves to the appropriate level before establishing the Earmarked Reserves, as the External Auditor indicated that the reserves were insufficient as of the year-end 31 March 2024.
